## Ocean Friendly Gardens Collaborative

Beyond the basic “Green Building” initiatives above, ACP Executive Director Dan Noble, had a half day strategy meeting (1/24/10) with the Surfrider Foundation, San Diego Coastkeepers and the County of San Diego Staff to develop an Ocean Friendly Landscapes and Gardens initiative in the region. A strategy and set of next step tactics were laid out and is found below. Also a set of websites already exist . A business plan and presentation (see ACP website) were also developed. In addition, Surfrider has published an Ocean Friendly Gardens (OFG) manual that provides an excellent introduction to sustainable landscaping that is friendly to oceans by minimizing surface runoff, protect against soil erosion as well as support landscape native habitat interfaces and build wildfire friendly and edible , sustainable landscapes.

The Surfrider Foundation in col-

laboration with the Green Gardens Group, with funding from West Basin Municipal Waste District,, have formed a very unique program to expand OFG’s on existing landscapes through a combination of principles : conservation permeability (CPR), hands on workshops (HOW) and the Gardener Assistance Program (GAP),. These principles combine the best education with help your neighbor by volunteering and with “pay it forward” and “Barn raising” methods, combined with professional leadership and administration.

## Carbon Credits for Compost Production

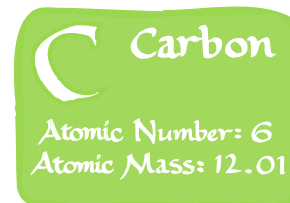
ACP’s Compost Carbon Credits Taskforce had a lot of activity in January 2010. Taskforce Chairman Thornton Schaaf (Carbon Solutions Group) was chosen to fill one of the 20 or so seats on the Climate Action Reserves (CAR) committee, thanks to all the support of the ACP and its members.

At the first meeting of CAR, “Compost Project Protocol Workgroup (Meeting #1), on February 2, 2010 from 1 to 3 PM PST the following highlights were listed by Thornton:

- *WG participants need to submit feedback on studies by February 8th*
- *Protocol will be distributed to WG participants Feb 12th.*
- *Protocol will address FOOD WASTE composting ONLY*
- *Concerns were raised on the exclusion of yard waste and biosolids. CAR has yet to determine if they will reconsider their inclusion*
- *CAR hopes to have this protocol*

*through the WG, public comment period and adopted by June 30th, 2010.*

Thornton Scaaf will continue to interact with the ACP Task Force, as well as the membership in general and we will have input in the process for the entire time of this CAR Compost Protocol.



## Pathogen Control with Compost

The California Department of Food and Agriculture (CDFA) on January 20, 2010, notified the “green waste industry” to inform them of an upcoming information sharing meeting regarding the recent detection of the Asian Citrus Psyllid in Orange and Los Angeles Counties and how detection may affect the green waste industry.

**WHERE:** Los Angeles County Arboretum, Ayers Conference Hall 301 N Baldwin Ave. Arcadia, CA 91007  
**TIME:** 10:00AM to Noon

A copy of the full letter is posted on the ACP website, along with a map of the meeting location and a map of the Asian Citrus Psyllid quarantine areas.

Briefly, the letter state, “The Asian citrus psyllid (psyllid), an insect pest known to vector citrus greening, a devastating disease of citrus, has been found in California in San

Diego, Imperial, Los Angeles, and Orange counties. As a result, the CDFA implemented a State Interior Quarantine that restricts the movement of host articles in an attempt to prevent the further spread of psyllid into other areas of California. **Green waste is among the articles covered by the quarantine.**

Further CDF stated, “It is our intent to work collaboratively with the green waste industry to identify and implement movement and handling protocols that will mitigate the risk of moving psyllid on green waste from infested areas. We have scheduled the information sharing meeting to develop practical and enforceable solutions to the issue of green waste movement out of the psyllid infested areas. It has been requested that , “To ensure a productive meeting, the CDFA is requesting that you come prepared to complete a questionnaire with the following information:

- Physical location and mailing

address of your green waste facility

- Method of processing green waste (e.g. grinding, chipping) and location where processing occurs if other than at the location above
- Final destination of green waste (type of facility and physical address).

ACP representatives intend to attend and participate in this meeting however, if your company either chip and grinds only or composts any green waste material, we highly recommend that you attend along with us. After the meeting we will hold an ACP task force meeting and specifically address a course of action for association members and non-members alike.

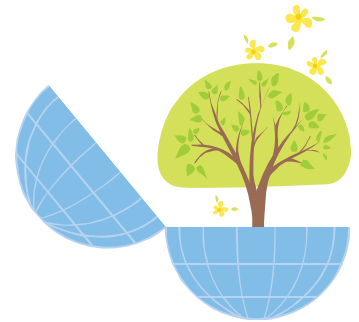
### SJVUAPCD Organic Waste Composting—Update



The San Joaquin valley Unified Air Pollution Control District (SJVUAPCD) held its most recent Organic Waste Technical Working Group meeting last week to report back and further discuss the “Organic Waste Composting Project” on which Dr. Fatih Buyuksonmez, SDSU, is the Chief Investigator. ACP members provided detailed feedback after reading and reviewing the report which will be used for VOC mitigation from compost operations and rule making this spring with the SJVUAPCD. The comments from the Technical Working Group

participants (close to two dozen from ACP members) were aggregated by Ms. Koshoua Thao, Air Quality Specialist, Project Manager for this project, received by ACP Thursday, February 4, 2010 and have been forwarded for her detailed review.

### Bifenthrin Containing Compost

A special roundtable discussion on Bifenthrin in California Compost, was held at the EcoFarm Conference on Thursday January 21, 2010. Bifenthrin containing compost has caused the loss of Organic Certification by three green waste composters in California. The key take home from this meeting is:

- There is not clear agreement as to if and why there should be zero tolerance for Bifenthrin in compost to maintain its organic input certification under the USDA National Organics Program.
- CDFA had to respond to a claim made by industry or the public on this issue in California
- Composters asked for a “moratorium” to retain their Organic Input Certification under USDA NOP until this issue is truly resolved
- The representative at the meeting from the USDA NOP program in Washington DC will go back and respond to the above request by April 2010, in time for the height of

the compost sale season.

While we have not received any formal notes from this meeting, we will report back and share them when they are available. “Bifenthrin in Compost” is a roadmap, “Core Issue” for Cal Recycling this year.

## Capitol Alert

On February 4th, 2010, an article was released by Capitol Alert stating the following information:

### INITIATIVE TO SUSPEND AB 32 CLEARED TO GATHER SIGNATURES

“A proposed initiative to suspend California’s landmark legislation to reduce greenhouse gas emissions was cleared by the Secretary of State’s office late Wednesday to begin collecting signatures.

A creator of the initiative, Assemblyman Dan Logue, R-Linda, said he has commitments of \$600,000 from businesses interests for a campaign to qualify the measure for the ballot.

The initiative would suspend implementation of Assembly Bill 32, which called for reducing California’s greenhouse gas emissions to 1990 levels by 2020. Logue and other opponents have argued that AB 32 would be extremely costly to businesses and take a heavy toll on the state’s economy. The proposed initiative would suspend the state’s greenhouse-gas reduction requirements until California’s unemployment rate, currently above 12%, falls below 5.5% or less for four consecutive quarters.

To qualify for the November ballot, backers of the initiative must collect 433,971 voter signatures by June 24th. To qualify for a 2011 special election or a 2012 statewide election, the deadline is July 5, the Secretary of State’s office said.

The initiative would, of course, derail the efforts by Californians for the pas 3-4 years who are diligently working and investing (with their time, money and energy) to make actual changes and progress to produce Climate Change results.”

ACP members are considering NOT supporting this measure.
