COMPOST LEGISLATION

SCAQMD— Proposed Rule 1133.3 & SJVAPCD— Proposed Rule 4566

As discussed in the Air Workshop article in this newsletter, ACP is directly involved in engaging with the two air districts to provide professional and industry input on these two Proposed Rules regarding air pollution control of Compost Piles. An outline of the issues (contained in the Air Write Up, http:// www.healthysoil.org/ acpinitiatives results / acpdocuments.html) include a Summary of the findings and action for Existing and New and Expanded compost cilities and Next Steps. The main findings are outlined here:

EXISTING FACILITIES

SCAQMD Proposed Rule 1133.3

- Rule has been delayed until first quarter of 2011.
- Will most likely focus on green material, not the end use

(i.e., the Rule will likely include storage times for chipped and ground material, regardless of end use, as well as mitigations for composting).

SCAQMD is looking to SJVAPCD process to see what composting mitigations might get adopted.

<u>SJVAPCD Proposed Rule</u> <u>4566</u>

- Rule was recently delayed until 2nd quarter of 2011.
- Have yet to complete socio-economic impact assessment, asking for more detailed financial information from existing compost facilities
- Existing composting facilities will need to mitigate VOCs, but mitigations appear financially acceptable (irrigation and/or compost cap)
- SJVAPCD looking at "tiering" the Rule, so larger

facilities do more intensive mitigation.

Existing facilities mitigating above requirements may be eligible for Emission Reduction Credits.

NEW & EXPANDED FACILITIES

SCAQMD

Unclear how Proposed Rule 1133.3 will affect new and expanded facilities.

SIVAPCD

New and expanded facilities will need to comply with existing Rule 2201 which will require New Source Review and likely emission offsets.

Average price of VOC offsets in the SJVAPCD is \$18,000 per ton.

CDFA

- New CDFA regulations are in effect as of 1/1/11 (January 1, 2011), based on AB 856
- Any composter selling an "Organic Input Material" will need to be licensed by CDFA and register "labels" for their products.

CDFA has promised compostspecific AB 856 workshops in 2011.

AB 856 (Caballero) Fertilizing Material: Organic Input Material

Existing law generally regulates fertilizing materials, as defined, and provides for the licensure of individuals who manufacture or distribute fertilizing materials. This bill would include organic input material, as defined, within the definition of fertilizing material, i.e. including compost.

Matt Cotton, IWM Consulting, will present a brief overview of this law at the ACP California USCC State Chapter Breakfast meeting. 
common goal of successful and sustainable organic resource management. Global Conference sessions focus on that
